**KBS REIT II Introduces Enhanced Amenity Package  
at Park Avenue at Morris County**

FLORHAM PARK, N.J. (July 8, 2014) – [KBS Real Estate Investment Trust II](#) (KBS REIT II), a Newport Beach, Calif.-based public, non-traded real estate investment trust, announces a new, best-in-class amenity package at its 1.15 million-square-foot [Park Avenue at Morris County](#), a Florham Park, N.J., office park.

[Recently added amenities](#) at Park Avenue at Morris County have created a true lifestyle experience at this trophy-quality asset in suburban New Jersey. Among the features is a fleet of private shuttles that service local amenities and provide access to the Madison New Jersey Transit Rail Station. Also incorporated is a new umbrella service and a mobile app that provides a one-stop shop for tenants to access the park's amenity offerings.

Other amenities at Park Avenue at Morris County include a new conference center, an upgraded dining facility and electric car charging stations. A new, full-service fitness center has been built that includes an outdoor cross-fit station, massage room and aerobic center. Trainers and a massage therapist will be available on-site with session appointments available via the mobile app. The app also links tenants to the park's food delivery program directly to the main café.

"We have been rolling out new concepts over the past year at Park Avenue at Morris County, all focused on making the tenant experience unmatched among its Class-A office property peers in this marketplace," said Shannon W. Hill, KBS senior VP/Market Leader. "We believe this is the premier office community in the market and these added services show a commitment by KBS REIT II to keep it that way. The results of these efforts are reflected in the building's growing occupancy.

"Our accomplishments to date represent only the first phase of a new platform dedicated to tenant services," Hill said. "We will continue to roll out new programs over the next 12 months."
