Information with Respect to Distributions for the Quarter Ended December 31, 2020

KBS Real Estate Investment Trust III, Inc. (the “Company”) declared monthly distributions during the quarter ended December 31, 2020. During the quarter ended December 31, 2020, the Company paid aggregate distributions of approximately \$27.5 million, including approximately \$16.0 million of distributions paid in cash and approximately \$11.5 million of distributions reinvested through the Company’s dividend reinvestment plan. The Company’s net loss attributable to common stockholders for the quarter ended December 31, 2020 was approximately \$0.2 million. The Company’s funds generated from operations, as defined by New York Regulation 16.9, during the quarter ended December 31, 2020 was approximately \$27.8 million. Funds generated from operations is defined by New York Regulation 16.9 to be net income (loss) adjusted so that depreciation allowances are not treated as an expense and principal payments due on debt are deducted. The Company funded its aggregate distributions paid for the period with current period cash flow from operating activities. The Company includes amortizing principal payments in the calculation of funds generated from operations but excludes principal payments required upon the sale of any underlying asset, refinancing or at loan maturity, as these payments relate to and are funded by other investing and financing activities.
