Information with Respect to Distributions for the Quarter Ended June 30, 2022

KBS Real Estate Investment Trust III, Inc. (the “Company”) declared monthly distributions during the quarter ended June 30, 2022. During the quarter ended June 30, 2022, the Company paid aggregate distributions of approximately \$22.5 million, including approximately \$13.4 million of distributions paid in cash and approximately \$9.1 million of distributions reinvested through the Company’s dividend reinvestment plan. The Company’s net loss attributable to common stockholders for the quarter ended June 30, 2022, was approximately \$16.2 million. The Company’s funds generated from operations, as defined by New York Regulation 16.9, during the quarter ended June 30, 2022, was approximately \$10.3 million. Funds generated from operations is defined by New York Regulation 16.9 to be net income (loss) adjusted so that depreciation allowances are not treated as an expense and principal payments due on debt are deducted. The Company funded its aggregate distributions paid for the period with \$16.0 million of cash flow from current operating activities, \$1.8 million of cash flow from operating activities in excess of distributions paid during prior periods and \$4.7 million of proceeds from debt financing. The Company includes amortizing principal payments in the calculation of funds generated from operations but excludes principal payments required upon the sale of any underlying asset, refinancing or at loan maturity, as these payments relate to and are funded by other investing and financing activities.
